## Investment Objective

Performance and risk characteristics approximate those of the commodity strategy "Picard Angst Commodity Index - Total Return™ (PACI TR)". The index is a balanced raw materials benchmark that was devised by Picard Angst AG and features conservative and transparent diversification rules.

## Investment Strategy

Replication of the base strategy is achieved through investments in USD-denominated futures contracts. The investment committee monitors the portfolio and may implement a market view by over- and underweighting individual positions within limits. The fund offers a transparent and cost-efficient opportunity to invest in the commodities market. Low correlations to traditional asset classes such as equities and bonds make the fund a suitable portfolio addition under diversification considerations and allow for the optimization of risk-return profiles.

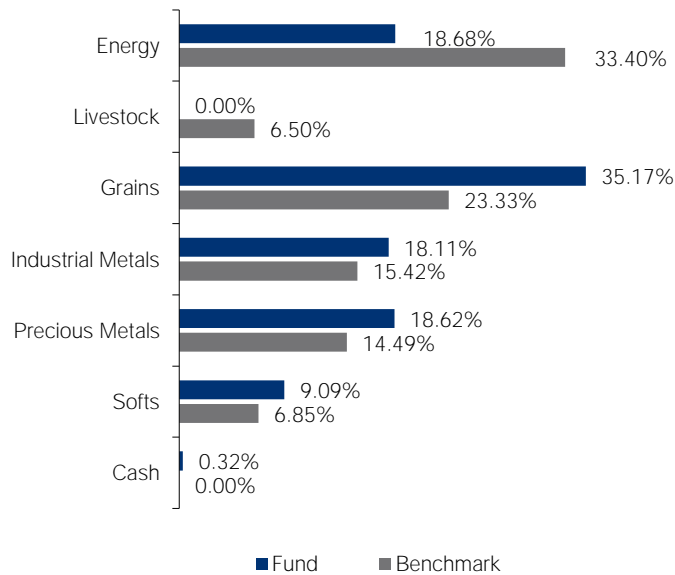
